Alfred,

Many groups have confused the BPA issues/polycarbonate and the "triangle 7 plastic" as one and the same. All polycarbonate bottles will have a "7" recycling code but not all "7's" are polycarbonate. "7" is just a recycling stream code and does not designate what type of plastic is in the bottles.

We continue to trust the FDA, the American Chemicals council and other reputable organizations that state polycarbonate is safe for drinking water.

Bisphenol-A Update

On June 11, 2008, Europe's Association of Plastics Manufacturers, known as PlasticsEurope, released a report on the findings of the European Commission's updated BPA risk assessment. The PlasticsEurope report stated that:

"In its updated risk assessment report of Bisphenol A (BPA) published today the European Commission concluded that products made from BPA, such as polycarbonate and epoxy resins, are safe for consumers and the environment when used as intended. This conclusion reconfirms the findings of the 2003 European risk assessment of BPA, and is consistent with conclusions of the scientific assessments of other regulatory bodies including the US FDA, the Japanese authorities and the European Food Safety Authority (EFSA)."
