

Since water is a crucial resource in all industries, managing its quality is vital. Triple Spiral Pipe

A Triple Spiral Pipe increases selfpurification of water by occurrence forces and centripetal forces. The product follows the theory that a natural river self-purifies by speed and curves, improving water quality.

 Activation Effect – Tap water passes through the pipe, becoming a "whirl flow" and many circular flows rise around it. The water moves violently and is activated. Bacteria are reduced and minerals are not lost.






