## High asbestos levels found in MA water

WESTFIELD, MA — Water commissioners will meet to discuss the recent discovery of asbestos in Eastwood Acres, MA, drinking water, according to

a Dec. 20 article by [The Republican](#).

*The problem was discovered when a sewer construction project revealed badly deteriorating asbestos-concrete water mains within Eastwood Acres, the article said.*

*According to the article, testing results for samples collected over the past several months have indicated asbestos levels as high as 29 million fibers per liter of drinking water, compared with the EPA maximum contaminant limit of 7 million fibers per liter.*

*During the most recent round of hydrant testing on Dec. 2, all but four of the 21 samples were below the EPA limit; residents in the area have been warned not to use tap water in a humidifier or vaporizer, the article said.*
